The "Hoosier Rewards" contingency program is available to drivers in every class that has a minimum of eight (8) karts competing in the class. Contingency awards are available to the following classes: Junior Gas, Junior One Light and Heavy, Junior One Animal Heavy, Junior Two Light and Heavy, Junior Two Animal Heavy, Stock Medium Animal, Stock Heavy Animal, Stock Heavy, Blue Wazoom Animal and Master Animal.

PROGRAM REQUIREMENTS:

1. Driver must use Hoosier kart tires on all four corners.
2. A minimum of two (2) Hoosier decals must be displayed on the kart.
3. Driver must have an IKF official sign this form verifying requirements #1 & #2 have been met.
