Requirements:	<ul style="list-style-type: none"> * Competitor must race with Hoosier Racing Tires on all four wheel positions, and with correct logo placement. * <u>Decals Required:</u> YES * <u># of Decals:</u> 4 * <u>Location:</u> One (1) 10" x 3.5" on <u>each side</u> and one (1)18" x 5" on center of the front and rear bumper. No competing tire decals (or patches) may be visible on the car or the drivers suits. <u>No exceptions</u> will be made for this rule. * <u>Availability:</u> Decals will be mailed once registered. Class Eligibility List:	<ul style="list-style-type: none"> * Competitors entered in the following American Rally Association (ARA) classes are eligible to participate in the 2019 Hoosier Racing Tire Contingency Program: * Open 4WD, Naturally Aspirated 4WD, Limited 4WD, Opend 2WD, Limited 2WD, UTV All ARA Regional & ARA National events. ("Stand Alone" Rally events are NOT eligible to be included in the contingency program) 			
Award Information:	<ul style="list-style-type: none"> * Product awards are presented to all eligible 1st, 2nd, 3rd and 4th place drivers in the ARA RALLY ASSOCIATION competition. Requirements outlined above: DNS are not counted in class count. * Contingency forms must be completely filled out and include all supplemental information; copy of official results, proof of purchase & photos. Original proof of purchase must be made available to Hoosier if requested. Tires must be purchased from an authorized Hoosier Racing Tire Distributor or a Track Side Support Dealer. * A minimum of five (5) competitors are required in a class to claim awards. * A maximum of four (4) tires will be awarded per vehicle, per race weekend. * Hoosier sponsored Rally Teams will not be eligible for contingency program. Contingency awards are non-transferable and are redeemable for tires only. * All awards must be claimed within 30 days of each eligible event. * See "Payout Schedule" below for award amounts.
